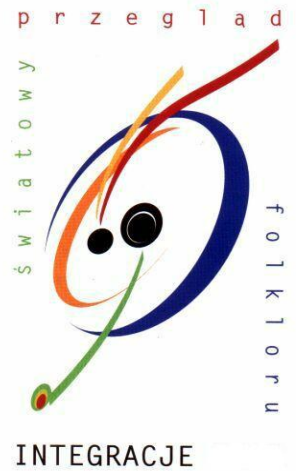


**24<sup>th</sup> WORLD FOLK REVIEW

AGREEMENT**

**§ 1**

**GENERAL INFORMATION:**

1. Only an adult group shall be accepted to participate in the 24<sup>th</sup> World Folk Review “Integration” 2024, (minimum age of participants is 18 years old).
2. The group may not be bigger than 30 people including bus drivers, managers, etc. For each extra person you need to pay a fee (30 euro per person for the entire visit – max. 5 persons). The number of the extra person should be report and pay by the end of July 2024.
3. The group should arrive to Poznan on August 8<sup>th</sup> 2024 till 6 p.m. and leave on August 18<sup>th</sup> after breakfast.
4. As the official language of the festival is English.

**§ 2**

**PERFORMANCES:**

1. Only live music performances shall be accepted (no possibility of playback or half playback performances).
2. The group should perform in original costumes and present various program lengths from 5 to 30 minutes.
3. All the concerts take place in the open air.
4. Participation in all points of the program is obligatory. The organizers will send a program to group by the end of June 2024.

5. During the Final Concert the group shall present pieces of its program chosen by the Artistic Director.
6. The group should prepare a national religious song or short dance that shall be performed during Ecumenical Mass.
7. The group is expected to take part in National Evenings that take place every evening. During that event each group will present their customs and traditions to the others, teach pieces of their dances and organize games.

### **§ 3**

#### **ACCOMODATION, FOOD, TRANSPORT:**

The organizers guarantee:

- for groups that travel by coach: filling up the coach with 200 litres of fuel at one particular filling station in Poznań. The organizers do not refund any other fuel expenses. The organizers do not pay off the coach renting cost;
- for groups that come to Poland by plane – means of transport within the polish borders;
- accommodation in two and three-person rooms with shared bathroom in student hostel(dormitory). Address of the accommodation: Dormitory of the University School of Physical Education, Św. Rocha street no. 9, 61-142 Poznań, Poland;
- three meals per day (starting with a dinner on August 8<sup>th</sup> and finishing with a breakfast on August 18<sup>th</sup>);
- free time for sightseeing the city – if the group will choose to visit a pay attractions, they need to cover the costs;
- mineral water for the group during all concerts;
- guide and interpreter in English.

### **§ 4**

#### **PROMOTIONAL MATERIALS:**

1. The group authorizes the organizer to use and publish all the photo and video material sent before the festival.
2. The group authorizes the organizer to use and publish all the photo and video material registered during the event.

### **§ 5**

#### **OTHER INFORMATION:**

1. Quiet hours applies from 11 p.m. to 6 a.m.
2. The costs of damage in the rooms or during the festival are covered by the responsible person or the group.

**INSURENCE:**

1. The organizers don't guarantee health insurance. The director of ensemble must take care of health insurance all members.

VISAS:

1. The group is obliged to arrange all the visa issues and reported on the effects to the World Folk Review 'Integration's organizers till 31<sup>st</sup> April 2024.
2. The groups that come to Poland by plane are obliged to send to the organizers the confirmation of the purchase of airline tickets by the end of April 2024.

## § 6

This agreement shall be executed in two counterparts, one for each party. After choosing groups, which will take a part in 24<sup>th</sup> World Folk Review "INTEGRATION" 2024, the organizers will sign it and send back to selected group.
